



Green Mountain Awards & Recognition

2008

- **August 2008** – Green Mountain ranked highest in customer satisfaction in Texas. In a study conducted by J.D. Power and Associates in June, 2008, Green Mountain ranked “**Highest in Residential Customer Satisfaction with Retail Electric Service**”. Four key factors went into this ranking: billing and payment, communication, customer service and pricing¹.
- **August 2008** – Green Mountain receives a **2008 Greater Austin Business “Take on Traffic” Award from the Greater Austin Chamber of Commerce** for the company’s green commuting program.
- **October 2008** – Green Mountain named as a finalist for **Platts 10th Annual Global Energy Awards** in the **Marketing Campaign of the Year** category.
